Memorandum of Understanding Between Peninsula Sunrise Rotary Club And Rotary Club of Redwood City, California, Inc.

This Memorandum of Understanding (MOU) defines the working relationship between the above organizations for the holding of an annual *Oktoberfest event* and *H20Open Door* projects.

I. DEFINITIONS

Oktoberfest. This consists of a Half Marathon, 5 K Run and a Color Run collectively called OktoberRun plus a festival to be held in Redwood City, California, consisting of stage performances, concerts, food, beer and vendors. The events will be run by the Sunrise Rotary Club's 501 c 3 organization as a charitable fundraising event.

H2OpenDoor project. The funds raised by the event will be used to purchase, transport and in conjunction with a local Rotary Club install water purification units in third world locations where we can make the best impact upon their health and their sustainability with appropriate training at these locations.

Open Door. A program which includes Teen and Community which teaches youth about giving back to the local community.

II. MISSION

The mission of Rotary International is to provide service to others, promote integrity, and advance world understanding, goodwill, and peace through its fellowship of business, professional, and community leaders.

Our mission is to promote H2Open Door projects, including providing assistance for the international water project and the local Teens & Community program through the Annual Oktoberfest event.

- III. Accordingly, the Rotary Clubs of Redwood City operating under this MOU agree as follows:
- A. Working together we will raise funds through Oktoberfest and OktoberRun to help accomplish the H2OpenDoor project and help our local high school kids study this project.
- **B.** Community Experience.

We will develop a Teens & Community volunteer group that will meet on a monthly basis and learn about Rotary. They will work with the Rotary Club Community Service committees to learn about giving back to their community and also participate in the two club's community service projects.

C. Expenses and Liabilities.

Unless approved in writing by the individual signing this MOU on behalf of the party to be charged, each party to this MOU is responsible for its own expenses. There will not be a reimbursement or exchange of funds between the parties for tasks associated with this MOU.

Rotary Club Of Redwood City does not have any financial obligation for contracts signed by Peninsula Sunrise Rotary Club, Redwood City Educational Foundation or any other organization involved in the Oktoberfest event or H20penDoors project.

D. Rotary Club of Redwood City shall use its best efforts to:

Oktoberfest

Assist in securing 30 vendors for the festival.

Assist in selling 25 coupon pages in the coupon book.

Provide 30 volunteers for the day of the festival.

Provide one person authorized to supervise youth activities to oversee the kids zone the day of the event.

Assist with the promotion of the event.

Encourage groups to participate in the running event.

Assist with raising of funds through the Oktoberfest event.

Open Doors

Develop a Teen & Community program that teaches youth about giving back to the local community.

Assist in identifying 2 youth and one teacher to travel to installation sites.

E. Peninsula Sunrise Rotary Club will:

Be responsible for all other aspects of the Oktoberfest event including receipt and disbursement of all funds.

F. The two Rotary Clubs of Redwood City together will:

Exhibit mutual respect for each other.

Work in a professional manner at all times.

Respect the confidentiality of member's contact information. This includes the lists of contacts and vendors which shall not be used by the non-owning party without the written permission of the other party.

IV. RESPONSIBILITIES

Each party will appoint a person to serve as the official contact and coordinate the activities of each organization in carrying out this MOU. The initial appointees of each organization are:

V. TERMS OF UNDERSTANDING

The term of this MOU is from the effective date of this agreement until June 30, 2014, and may be extended upon written mutual agreement. It shall be reviewed at least periodically to ensure that it is fulfilling its purpose and to make any necessary revisions.

Either organization may terminate this MOU upon thirty (30) days written notice without penalties or liabilities.

Written notices required under this MOU shall be delivered to the mailing address of record of the respective parties or care of the current President of the applicable club.

VI. Authorization

The signing of this MOU is not a formal undertaking. It implies that the signatories will strive to reach, to the best of their ability, the objectives stated in the MOU. On behalf of the organization I represent, I wish to sign this MOU and contribute to its further development.
